AUTHORITY TO ISSUE EXECUTIVE ORDERS

- Governor Newsom proclaimed a State of Emergency on March 4, 2020, when there were 53 confirmed cases of COVID-19 in California. Today, there have been over 330,000 confirmed cases statewide.
- During a State of Emergency, a Governor may suspend laws and issue executive orders necessary to carry out executive powers. (Government Code Sections 8567, 8571)
- To date, Governor Newsom has issued 47 Executive Orders, some of which are still in effect to begin the 2020-2021 school year

AUTHORITY TO ADOPT PUBLIC HEALTH ORDERS

- Love v. Superior Court (1990) 226 Cal.App.3d 736
 - *It is . . . undisputed that the control of a communicable disease is a valid exercise of the state's police power.*

- In re Johnson (1919) 40 Cal.App. 242, 244
 - *The adoption of measures for the protection of the public health is universally conceded to be a valid exercise of the police power of the state, as to which the Legislature is necessarily vested with large discretion, not only in determining what are contagious and infectious diseases, but also in adopting means for preventing the spread thereof.*

AUTHORITY TO ADOPT PUBLIC HEALTH ORDERS

- Health and Safety Code Section 120140:
 - Upon being informed by a health officer of any contagious, infectious, or communicable disease **the department may take measures as are necessary to ascertain the nature of the disease and prevent its spread.** To that end, the department may, if it considers it proper, take possession or control of the body of any living person, or the corpse of any deceased person.
- Health and Safety Code Section 120175:
 - **Each health officer** knowing or having reason to believe that any case of the diseases made reportable by regulation of the department, or any other contagious, infectious or communicable disease exists, or has recently existed, within the territory under his or her jurisdiction, **shall take measures as may be necessary to prevent the spread of the disease or occurrence of additional cases.**

PUBLIC HEALTH GUIDANCE/ORDERS

- **CDPH Industry Guidance: Schools and School-Based Programs (June 5, 2020)**
 - Non-mandatory — “Should be implemented only with county health officer approval”
- **CDE: Stronger Together (June 8, 2020)**
 - Optional guidance.
- **CDPH Guidance for the Use of Face-Coverings (June 18, 2020)**
 - Mandatory — overrides contrary local orders.
- **CDC Considerations for K-12 Schools: Readiness and Planning Tool**
 - Optional “readiness and planning tool.”
- **SB 98**
 - Distance Learning authorized, in part, “as a result of an order or guidance from a state public health officer or a local public health officer”

SB 98: IN-PERSON INSTRUCTION AND DISTANCE LEARNING

➤ Education Code Section 43502.

- (a) For purposes of calculating apportionments for the 2020–21 fiscal year, a local educational agency **shall offer in-person instruction**, and may offer distance learning, pursuant to the requirements of this part.

➤ Education Code Section 43503.

- (2) **Distance learning may be offered under either of the following circumstances:**

- (A) On a local educational agency or schoolwide level **as a result of an order or guidance from a state public health officer or a local public health officer**.
- (B) For pupils who are medically fragile or would be put at risk by in-person instruction, or who are self-quarantining because of exposure to COVID-19.

➤ Education Code Section 43504.

- (b) A local educational agency **shall offer in-person instruction to the greatest extent possible**.

SB 98: DISTANCE LEARNING

Distance Learning when offered must include:

- Daily live interaction with certificated employees and peers as part of regular instruction when feasible
- Daily tracking and weekly monitoring to verify participation and progress
- Access to connectivity and devices
- Content at a level substantially equivalent to in-person instruction
- Academic and other supports to students not performing at grade level
- Necessary accommodations for special education students and integrated instruction for English learners

SB 98- LAYOFF AND RELEASE OF SCHOOL EMPLOYEES

- Layoff of custodial, nutrition and transportation employees shall not be implemented in 2020-21 putting action taken between May 2 and June 30 by school boards or the county superintendent at risk
- Release of custodial, nutrition and transportation employees may be for good cause only in 2020-21
- Certificated employees in positions requiring an administrative or supervisory credential may be subject to the “Summer Layoff” statute


IS THERE INCREASED RISK ARISING FROM REOPENING SCHOOLS?
