General Announcements

White House Launches Office of Pandemic Preparedness and Response (OPPR)

As part of the President's commitment to ensure that our country is more prepared for a pandemic than we were when he took office, the Administration is standing up the OPPR. This will be a permanent office in the Executive Office of the President (EOP) charged with leading, coordinating, and implementing actions related to preparedness for, and response to, known and unknown biological threats or pathogens that could lead to a pandemic or to significant public health-related disruptions in the United States. OPPR will take over the duties of the current COVID-19 Response Team and Mpox Team at the White House and will continue to coordinate and develop policies and priorities related to pandemic preparedness and response.

To lead this work, the President announced that Major General (ret) Paul Friedrichs will serve as the inaugural Director of OPPR and Principal Advisor on Pandemic Preparedness and Response as of August 7, 2023.

HHS ASPR Hospital Preparedness Program Medical Response and Surge Exercise (MRSE) Rollout Webinar

ASPR will hold the MRSE rollout webinar on **Thursday**, **July 27**, **2023**, **from 3 PM – 4 PM ET**. During the webinar, the MRSE team will review updates that have been made to the MRSE Exercise Planning and Evaluation Tool. The tool has been re-designed to be more user-friendly and intuitive, incorporate a streamlined version of the Surge Estimator Tool (SET), and simplify patient tracking data inputs. The MRSE team will also go over updates to the MRSE Situation Manual, which provides optional guidance to better support Health Care Coalitions (HCCs) by including additional, non-core HCC members in the exercise. During this webinar, the MRSE Support Team will walk through these updates and demonstrate how HCCs can use the tool to capture exercise data. The Support Team will also be available to answer questions during the webinar.

ASPR TRACIE Resource Spotlight: Extreme Heat Resouces



Many ASPR partners are responding to extreme heat events in their communities. HHS Office for Civil Rights (OCR) and the Federal Trade Commission (FTC) Warn Hospital Systems and Telehealth Providers about Privacy and Security Risks from Online Tracking Technologies



The OCR and FTC are cautioning hospitals and telehealth providers about the privacy and security risks related to the use of online tracking technologies that may be integrated into their websites or mobile apps that may be impermissibly disclosing consumers' sensitive personal health data to third parties. Tracking technologies are used to collect and analyze information about how users interact with websites or mobile apps. Generally, tracking technologies developed by third parties send information directly to the third parties who developed such technologies and may continue to track users and gather information about them even after they navigate away from the original website to other websites.

U.S. Food and Drug Administration (FDA) Approves New Drug to Prevent Respiratory Syncytial Virus (RSV) in Babies and Toddlers



Last week, the FDA approved Beyfortus (nirsevimab-alip) for the prevention of RSV lower respiratory tract disease in neonates and infants born during or entering their first RSV season, and in children up to 24 months of age who remain vulnerable to severe RSV disease through their second RSV season.

CDC to Reopen Public Health Crisis Response Notice of Funding Opportunity (NOFO)

CDC plans to reopen the current Public Health Crisis Response NOFO, TP22-2201, in early August on www.grants.gov. The NOFO will remain open for 60 days to allow for applications from local health departments or tribes that meet eligibility requirements due to population changes. The list of eligible jurisdictions will be listed in the NOFO. CDC will reopen the funding announcement annually during the NOFO's five-year performance period to ensure CDC maintains a current roster of eligible jurisdictions for public health emergency response funding. The Public Health Crisis Response Cooperative Agreement approved but unfunded roster currently includes 97 jurisdictions. They include the 50 states, eight U.S. territories and freely associated states, 38 local jurisdictions, and one tribal government. The 2022 roster expires January 31, 2027.

Centers for Medicare and Medicaid Services (CMS) Approves California and Kentucky Requests to Provide Essential Behavioral Health Services Through Mobile Crisis Intervention Teams



"California and Kentucky recognize the vital importance of breaking down barriers to meet people in crisis with the care they need," said CMS Administrator Chiquita Brooks-LaSure. "With these approvals, California and Kentucky join a growing number of states in helping connect people to qualified health professionals as the first point of care during a crisis. This ensures people can get the care they need when and where they need it."

American College of Emergency Physicians (ACEP): Pediatric Emergency Care Improved During the Pandemic, New Assessment Shows



Despite significant resource and staffing challenges throughout the pandemic, emergency departments demonstrated notable improvements in pediatric emergency care. ACEP recently published the National Pediatric Readiness Project (NPRP) 2021 assessment was just published in JAMA Network Open which reflects progress since the prior assessment in 2013.

Domestic Preparedness Journal: Long-Term Care Facilities in Emergency Preparedness Planning



An important part of community emergency preparedness planning includes long-term care facilities such as nursing homes, dialysis, home care centers, or hospice facilities. Older adults and those with disabilities have increased vulnerability during emergencies. This population may have more limitations, require additional support, and may experience health emergencies sooner than others when faced with limited food, drink, rest, or access to electricity.

New Toolkit Available for Monitoring and Surveillance of Behavioral Health After Disasters



CENTERS FOR DISEASE CONTROL AND PREVENTION

With the support of CDC's Office of Readiness and Response, RAND Corporation researchers have developed a practical online and interactive toolkit for state, territorial, local, and tribal public health departments. The toolkit can assist with conducting behavioral health surveillance following disasters and other public health emergencies. With improved monitoring and surveillance of behavioral health precursors and impacts, public health officials can

- Follow long-term trends and better anticipate the potential impacts of emergencies;
- Identify sudden increases in behavioral health needs;
- Evaluate the equity and effectiveness of interventions for conditions such as depression, anxiety, and substance use; and
- Position resources to prevent adverse behavioral health impacts from future emergencies.

This toolkit shows how existing data sources can be used for behavioral health surveillance in the context of a variety of public health emergencies. These sources include unemployment insurance claims, 2-1-1 hotline calls, calls to Poison Control Centers, prescription drug fills, sales of over-the-

counter sleep aids, and use of emergency departments and emergency medical services. The toolkit is publicly available and free to access.

ASTHO: Preparing for the Next Public Health Crisis



Staff from ASTHO and Thomas Dobbs, the former Mississippi state health officer, have co-authored a commentary in the *Journal of Public Health Management and Practice* on preparing for the next pandemic or public health crisis. The commentary describes how COVID-19 and other recent crises have highlighted the importance of accurate communication, depoliticizing public health, securing funding, and implementing policy solutions to prepare for future outbreaks. Additionally, the piece addresses how health equity and community engagement will be crucial for effective pandemic responses.

ASTHO: When There's Fire, There's Smoke - States Prepare for Health Impacts of Wildfire Smoke



With wildfire season kicking off this summer with <u>fires in Canada causing air quality issues</u> in many parts of the United States, state health agencies are preparing for and responding to the impact of wildfire smoke on community health. According to CDC, <u>wildfire smoke inhalation</u> can cause any number of symptoms, including coughing, chest pain, shortness of breath, and asthma attacks. As the <u>United States begins to see more wildfires</u> during increasingly dry and hot summers and falls, it is important for health agencies to be ready to address concerns from the public and collaborate with other state agencies, like environmental or natural resource agencies, to mitigate the health risks of wildfire smoke.
