## **Coronavirus Adds to Complications Heading into Hurricane Season**

The National Oceanic and Atmospheric Administration said there is a 60% chance the 2020 hurricane season will have "above-normal" activity, [according to a press release from the agency](#). It expects 13 to 19 named storms, of which six to 10 would become hurricanes.

As hurricane season approaches, the ongoing coronavirus pandemic adds another variable for supply chain managers to consider when navigating what can already be a disruptive period.

Cargo volume slid at ports across the country in April, and ocean carriers have responded to the lack of demand by [canceling a record number of sailings](#). ## Federal Government to Distribute Nearly 100 Million Cloth Facial Coverings for Transportation Passengers

The Federal government [announced nearly 100 million cloth facial coverings will be sent to the aviation, transit, and passenger rail transportation sectors for passenger use](#). Approximately 86.8 million coverings will be distributed to airports, and 9.6 million coverings will be distributed to 458 transit agencies and Amtrak for passenger use.

## U.S. Food and Drug Administration (FDA) Supply Chain Updates

**FDA Reissues Emergency Use Authorizations Revising Which Types of Respirators Can Be Decontaminated for Reuse**

In response to public health and safety concerns about the appropriateness of decontaminating certain respirators, the U.S. Food and Drug Administration (FDA) [reissued certain emergency use authorizations \(EUAs\)](#) (current as of 6/7/20) to specify which respirators are appropriate for decontamination.

### **FDA Takes Action to Protect Public Health and Increase Supply of Alcohol-Based Hand Sanitizer**

The [FDA has taken additional action](#) to help ensure widespread access to hand sanitizers during the COVID-19 public health emergency. FDA updated guidances (current as of 6/1/20) to provide additional clarification on the manufacturing and compounding of certain alcohol-based hand sanitizer products to help ensure that harmful levels of impurities are not present in ethanol used in hand sanitizer.
